

# **UMATI REPORT JULY to NOVEMBER 2017**

# 1. UMATI subscriptions

At an UMATI Board meeting of 25/7/2017 attended by all Board members and representatives from the associations MMAA, KVA and NRLA and MIP, it was tabled and accepted that UMATI would request a monthly contribution of R6000 each from these organisations from November 2017.

UMATI is now a registered NPC and the application for registration as PBO (Public Benefit Company) is in its final stages with our consultants and auditors Colenbranders Inc.

Thank you to these Associations for their positive response to this commitment for 12 months until the situation is reassessed prior to the end of that period.

UMATI has just finalised their new Standard Bank account and this will be controlled by Tony Le Roux out of MMAA offices.

#### 2. UMATI website

In addition, AFRA (Association for Rural Advancement) interviewed UMATI for a documentary, focusing on commercial farmers being land owners and farm dwellers.

## 5. Support for UMATI

A number of banks and businesses have agreed to support UMATI in the interests of transformation to sustain the viability of their commercial farmers. These include Standard Bank, AAM, Mascor, Gromor, TWK and Danone as well as several others still to be confirmed.

## 6. Upgrading Kamberg tourism

UMATI with CLR Richard Khumalo have held meetings with DARD and Ezemvelo about projects that would upgrade all tourism activities at Kamberg Nature Reserve and benefit the Thendela community living there. This would involve a joint venture with the community. With assistance from UMATI, James Martin on behalf of Umgungundhlovu has already started some projects at Thendela.

# 7. Umgungundhlovu Water Resource Project

The original MIP dam building project now known as "UMGUNGUNDHLOVU WATER RESOURCE PROJECT" was presented to the Umgungundhlovu District Council on 3 October 2017 and approved.

Subsequently the Mayor the HON CLR TE MAPHUMULO visited the proposed dam sites on the Little Mooi in the Kamberg and Hlatikulu and gave her undertaking that her Council would support the scheme. This has resulted in a process whereby land procurement for the dam will be expedited as it now becomes a community-based project for the benefit of all.

Further work is now to continue with our consultants MBB and interaction with DWS. A meeting has been arranged with DWS to inform them of these developments and to plan the way forward with this ground-breaking water resource project that has the capacity to benefit the entire community of the Mpofana catchment area.

It is a model based on three pillars: INFRASTRUCTURE, EDUCATION & RADICAL TRANSFORMATION.

#### 10. Municipal FPSU (Farmer Production Support Unit)

UMATI members continue to support our Municipal FPSU (Farmer Production Support Unit) and AGRIPARKS. This has involved a great deal of time and attending meetings with all role players including DARD, DRDLR, municipal officials and other NGOs. The main objectives have been to advise Government organisations on how best to re-establish the developing farmers who have CPA and State owned lands that are no longer productive. This has included a number of farm and CPA visits. There is some progress in this and Government has recently allocated R71m to this cause. As neighbours and responsible citizens we cannot sit back and watch any more Developing Farm failures.

#### 11. AGRITECHNA EXHIBITION

James Kean, Chairperson of UMATI, attended the AGRITECHNA EXHIBITION in Hanover, Germany from 14 - 19 November. Apart from the fact that James strives to keep his farming at a high tech level and the exhibition being one of the most advanced in the world of this type, he also used this opportunity to discuss UMATI with European agriculturists interested in agriculture in Africa.
